## SLA ENFORCEMENT

Members would have received and noticed several announcements advising the stepped up spot-checks by SLA Enforcement Officers.

CGC has been issued warning on safe management measure infringements arising from SLA's enforcement spot-checks. As tasked by SLA Enforcement Officers, CGC has issued warning letters to members who have been identified infringing these measures.

Please be informed that CGC will continue to be vigilant and will be enforcing Safe Management Measures in accordance with the Ministry of Health and government directives; and, CGC's Bye-Law and Control Order.

Repeat infringers will be asked to leave the Club premises and/or have their Club privileges suspended.

Recalcitrant violators will be reported to the authorities for their appropriate action.

## SAFE MANAGEMENT MEASURES

We seek your cooperation and compliance to keep CGC, our members and staff safe:

- If unwell, seek medical attention and stay at home
- Use Safe-Entry registration on entering and exiting the Club's premises
- Exercise minimum 1-metre safe distancing and practise personal hygiene at all times
- Maintain 5 persons to a table, including standing
- Leave the Club premises by 22:30hrs
- Wear your masks when not eating or drinking

In addition, please note the 5-person capacity limit at #345 and the Halfway House.

The Club will continue to suspend all club golf and social events, including competitions, and, close some of our facilities: Function Room, Karaoke and Games/Mahjong Room.
